The support provided by AHF includes funds for teachers, doctors, medicine, food, shelter, clean water and other infrastructure projects, post-earthquake rebuilding, vocational training, and a wide range of other kinds of services that directly benefit the people by responding to their most basic needs. The projects respond to the priorities of their communities, in a way that respects both tradition and innovation.
